Yoon Kim, County Administrator, explained the Budget Amendment for FY 2025 added \$850,000 for expenditures to appointed attorneys, reflecting a 17% increase due to rising case numbers and population growth. Commissioner Fletcher noted the importance of adjusting future budgets as the population increases and commended staff for addressing the issue. Mr. Kim confirmed the FY 2026 budget currently matched FY 2025 and said a future adjustment would be needed. With no further discussion, a motion

Commissioner Webb reported that the RTC (Regional Transportation Council) met on October 9th and approved priorities for the Federal Surface Transportation Act including adequately funding the transportation system, streamlining project delivery through formula allocation, pursuing safety through technology, expanding options, and increasing efficiency. He noted concerns that future county funding could be impacted by the shift away from formula allocation at the State level.

Commissioner Webb described the long-standing east-west revenue allocation policy, explaining that the current ratio of 81.1% east to 18.9% west was the most imbalanced in years due to major eastern projects. He said he expected future grants to favor the west side as new projects emerged.

Commissioner Webb stated that transportation planning was underway for nine World Cup soccer matches scheduled in the DFW area next summer, including seven weekday games and one semifinal. (Time: 1:40 p.m.)

Barbara Dawn Lyke, Wylie, recognized October as Breast Cancer Awareness Month and highlighted ongoing studies aimed at improving treatments for breast and other cancers, including bone, skin, brain, heart-related, and colon cancers. She explained the STAR trial (The Study of Tamoxifen and Raloxifene) and noted that while survival rates have improved, continued financial support is vital. Ms. Lyke commended Baylor Scott & White Dallas Foundation for raising over \$42 million in 25 years to advance breast cancer treatment in North Texas and expressed hope for continued progress in cancer prevention and care. Commissioner Fletcher thanked Ms. Lyke for her advocacy. (Time: 1:44 p.m.)
