Benefits to County and Citizens

The \$100,000 budget supports the Collin County Misdemeanor Veterans Treatment Court, with \$94,000 allocated to direct client services, including counseling, alcohol monitoring, and basic living assistance, and \$6,000 for indirect costs. Indirect costs cover essential program and office supplies, office equipment, technology, professional services, subscriptions, training materials, therapy books, therapy supplies, and participants basic needs to support daily operations and service delivery. These services help justice-involved veterans address underlying mental health and substance use challenges, promote accountability, and foster long-term stability. By strengthening veteran outcomes, the program enhances public safety, reduces jail costs, and supports successful reintegration into the community—all without creating additional financial burden to the county.
