



**INTERLOCAL COOPERATION CONTRACT

AMENDMENT NO. 6**

The **General Land Office (GLO)** and **Collin County, Vendor ID 75-60008736** (Receiving Agency), are parties to that certain Interlocal Cooperation Contract No. 14-281-000-8451, entered into effective June 1, 2014, referred to herein as the Contract.

Now therefore, the parties agree to amend the Contract effective June 1, 2026 as follows:

1. Section 1.01 is deleted in its entirety and replaced with the following:

"1.01 Term: This contract shall be effective June 1, 2014 through May 31, 2028;
HOWEVER, the Contract shall be extended for each subsequent biennium if the requisite funding is appropriated by the Texas Legislature for the GLO and Receiving Agency for such biennium."
2. Exhibit A to the Contract is amended and supplemented by adding the Revised Exhibit A, attached hereto and incorporated herein in its entirety for all purposes.
3. Exhibit B to the Contract is amended and supplemented by adding the Revised Exhibit B, attached hereto and incorporated herein in its entirety for all purposes.

Except as amended and modified herein, the terms and conditions of the Contract remain in full force and effect.

INDEX GAS PRICE: Effective June 1, 2026, an Index Gas Price equal to the Index Price posting as first published each month in Platts Gas Daily Price Guide report in section titled "Monthly Bidweek Spot Gas Prices, (Month) – Platts Locations" under the heading "East Texas" and under the subheading "NGPL, Texok zone" plus a Market Demand Factor of \$0.40 per MMBtu.

SWING GAS PRICE: For physical volumes delivered that are not priced under Fixed Gas Price or Index Gas Price, all volumes purchased in excess of the Fixed Gas Price and Index Gas Price volumes nominated at the first of the month for the delivery months will be the average price of the Platt's Gas Daily price under the heading "East Texas" and under the subheading "Atmos Zone 3" plus a Market Demand Factor of \$0.55 per MMBtu. Any shortfall volumes sold for the delivery months, shall be credited at the monthly average price of the Gas Daily NGPL, Atmos Zone 3 index as published in the Platts Gas Daily, Final Daily Price Survey minus \$0.25 per MMBtu.
