2. **General Discussion Items:**

Presentation, discussion and any action regarding:

a. AI-60274 Support for Increasing Texas County Road and Bridge Fee for County Transportation Projects, Commissioner, Precinct 3.

Commissioner Hale explained that the Texas County Road and Bridge Fee had not been adjusted since 1991 and noted that inflation had increased approximately 236% during that period. He stated that the proposed increase to \$20 remained below the amount that would reflect inflation but would still provide additional funding for County Transportation Projects. Commissioner Hale said that the Road and Bridge Fund may require supplementation from the General Fund in the coming year due to existing fund allocation structures and budgetary considerations. Following approval, Judge Hill stated that the resolution would be forwarded to the County's legislative delegation for consideration during the upcoming legislative session. (Time: 1:34 p.m.)

b. **AI-60224** Creation of a full time Title Specialist position in the Tax Office approved in the fiscal year 2025 budget, and budget amendment in the amount of \$28,060 for same, Tax Assessor Collector.

Scott Grigg, Tax Assessor, explained that a full-time Title Specialist position had previously been approved and funded in the Fiscal Year 2025 budget, but the position had remained unfilled until existing staff obtained the experience and training necessary to perform title work. He noted that title transactions required substantially more training and documentation than registration transactions. Commissioner Hale expressed appreciation for the decision to delay filling the position until qualified personnel were available. Yoon Kim, County Administrator, confirmed that funding for the position had been held in Contingency and was available for the requested action. (Time: 1:36 p.m.)

d. **AI-60269** Regional Transportation Council monthly update, Commissioner, Precinct 3.

Commissioner Hale provided an update from the RTC (Regional Transportation Council) meeting. He reported that the RTC lawsuit remained set for trial in November, 2026. Commissioner Hale noted that FIFA (International Federation of Association Football) related events were ongoing, and the RTC had approved additional funding for those efforts. Commissioner Hale stated that a tri-party agreement had been passed between the RTC, the NCTCOG (North Central Texas Council of Governments), and TxDOT (Texas Department of Transportation), and would be forwarded to the Executive Board for consideration. He also reported on a proposed TEXRail extension to the hospital district, including the use of previously approved funding. In response to Commissioner Webb, Commissioner Hale confirmed that he voted in favor of the TEXRail extension funding request. Commissioner Hale reported that the RTC approved a transit study examining potential rail service between Plano and McKinney and noted that discussion emphasized a broader transportation planning effort, including consideration of U.S. Highway 75 as interim solutions are evaluated pending identification and implementation of a rail corridor. He further discussed development of the RTC Transit Vision Plan, reviewed updates regarding state funding for the 10-year plan, and reported on nominations for the RTC's upcoming officer elections. 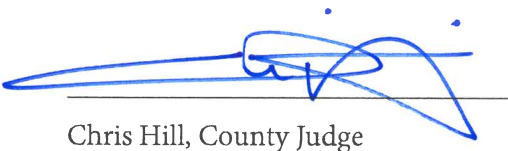
3. Executive Session Items:

AJ Wilson of North Richland Hills spoke in opposition to the Double R MUD (Municipal Utility District). Citing his personal experience living under Islamic governance prior to immigrating to the United States, Mr. Wilson expressed concerns that the proposed development could create a politically and culturally concentrated community with significant influence on local governance and elections in neighboring Hunt County. He also raised concerns regarding potential financial risks to Collin County associated with the MUD's financing structure and urged the Court to exercise its oversight authority and support ongoing legal efforts to dissolve the MUD. (Time 1:45 p.m.)

There being no further business of the Court, Judge Hill adjourned the meeting at 1:45 p.m.



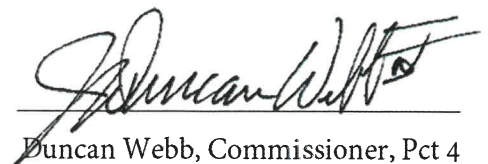
