Judge Hill questioned Change Order No. 29 and requested clarification regarding contractual obligations, responsibility for tariff refunds, and the County's ability to recover funds if refunds were later issued. He noted the contract did not address and expressed concern that the County should not approve payment without assurance that any refunded amounts would be returned to Collin County. Marci Chrismon, Assistant Purchasing Agent, stated staff proceeded with the request to avoid delays to the ARPA (American Rescue Plan Act) funded project. Sandeep Kathuria, Director of Building Projects, clarified that TKE (TK Elevator) was withholding final elevator inspections until the tariff costs were paid. Mr. Kathuria confirmed the elevator installation was complete and stated the inspection process required TKE participation. Judge Hill emphasized that he did not want either The Christman Company or TKE to receive payment from the County and reimbursement from the federal government for the same tariff expense. Commissioner Fletcher stated the Court could not risk delays that might jeopardize ARPA funding. Yoon Kim, County Administrator, reiterated staff concerns that withholding payment could halt project progress and threaten ARPA compliance deadlines. Mr. Kim stated staff would seek written confirmation from the contractors that they would pursue available tariff refunds and return any refunded amounts to the County. Commissioner Webb requested clarification regarding documentation requirements. Ms. Chrismon stated the agreement would require notification of any tariff reductions, refunds, or credits and allowed the County to request documentation or an audit trail showing whether refund efforts had been pursued, but it did not require the contractor to seek reimbursement.

Judge Hill asked how the proposal aligned with the Court's efforts to reduce Hospital Watch and Constant Watch overtime. Matt Langan, Chief Deputy Sheriff, stated the change would dedicate the positions to Hospital Watch, medical runs, and Constant Watch duties and improve staffing efficiency. Commissioner Hale questioned whether converting the positions to 80-hour schedules would reduce available staffing hours. Michael Sepulvado, Assistant Chief Deputy Sheriff, explained the reassignment would allow the positions to cover hospital guard assignments and medical transports more efficiently due to the division's smaller relief factor. Commissioner Fletcher expressed concern that the change could increase overtime costs. Mr. Langan stated that the 10 new positions were expected to significantly reduce, but not completely eliminate, overtime associated with guarding inmates at hospitals. The department planned to monitor the effectiveness of the positions and noted that additional personnel requests could be made in the future if needed. (Time: 2:00 p.m.)

2. General Discussion Items:

Presentation, discussion and any action regarding:

a. AI-60046 Web Content Creator Policy, Information Technology.

Tim Nolan, IT Senior Manager, presented a proposed website governance policy intended to ensure County webpages remained ADA (Americans with Disabilities Act) compliant, maintained consistent branding, and functioned properly across all devices. Mr. Nolan stated the policy established guidelines for County employees and other third-party content creators responsible for maintaining webpage content. He outlined requirements related to accessibility standards, branding consistency, responsive webpage design, content maintenance, and editor training. Mr. Nolan stated the policy limited each department to four webpage editors and required completion of training before access would be granted. He also noted ongoing efforts to improve PDF accessibility and future plans to expand automation and artificial intelligence tools within the County's website platform. Mr. Nolan explained the proposed workflow for webpage updates, including compliance validation, IT support for new pages, and review by the Public Information Office (PIO) for style and messaging consistency, and publication procedures. He stated emergency updates would be exempt from the standard workflow process. Mr. Nolan further described a tiered remediation process for policy violations focused on education, corrective action, and potential suspension of editing privileges for repeated noncompliance. 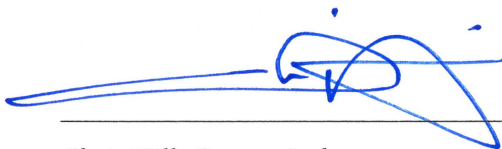
Commissioner Hale provided an update from the Regional Transportation Council (RTC) meeting and specifically highlighted items 5, 6, and 8. Regarding item 5, Commissioner Hale reported on a proposed tripartite agreement among the North Central Texas Council of Governments, the RTC, and TxDOT (Texas Department of Transportation), noting ongoing disputes regarding MPO (Metropolitan Planning Organization) authority that are also the subject of litigation involving Denton County. In reference to item 6, Commissioner Hale stated the body moved to begin negotiations regarding the potential appointment of Michael Morris as Transportation Director, despite concerns raised regarding compliance with North Central Texas Council of Governments bylaws governing hiring authority. Pertaining to item 8, Commissioner Hale highlighted the Safe Streets and Roads for All grant program and noted that while the County currently participates through regional entities, it may also be eligible to apply directly. He suggested future discussion regarding direct County participation and potential grant coordination capacity. (Time: 2:17 p.m.)

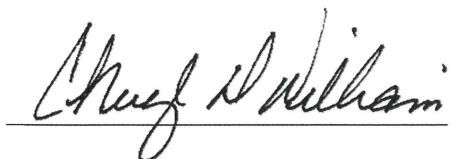

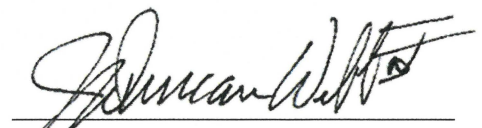
