ELECTED OFFICIAL COMPENSATION POLICY

For FY2026, Commissioners Court approved a new policy for elected official compensation. The policy determines how the approved increase percentage will be applied and the resulting salary for the new fiscal year, if approved by court.

Per policy, the 5th and 6th placed salaries from the comparison counties, excluding Collin County, are averaged, then the approved increase percentage is applied to this average. The resulting amount is the new salary for the following fiscal year.

If the elected official's current salary is over the average of the 5th and 6th placed salaries with the approved increase percentage applied, the elected official maintains their current salary.

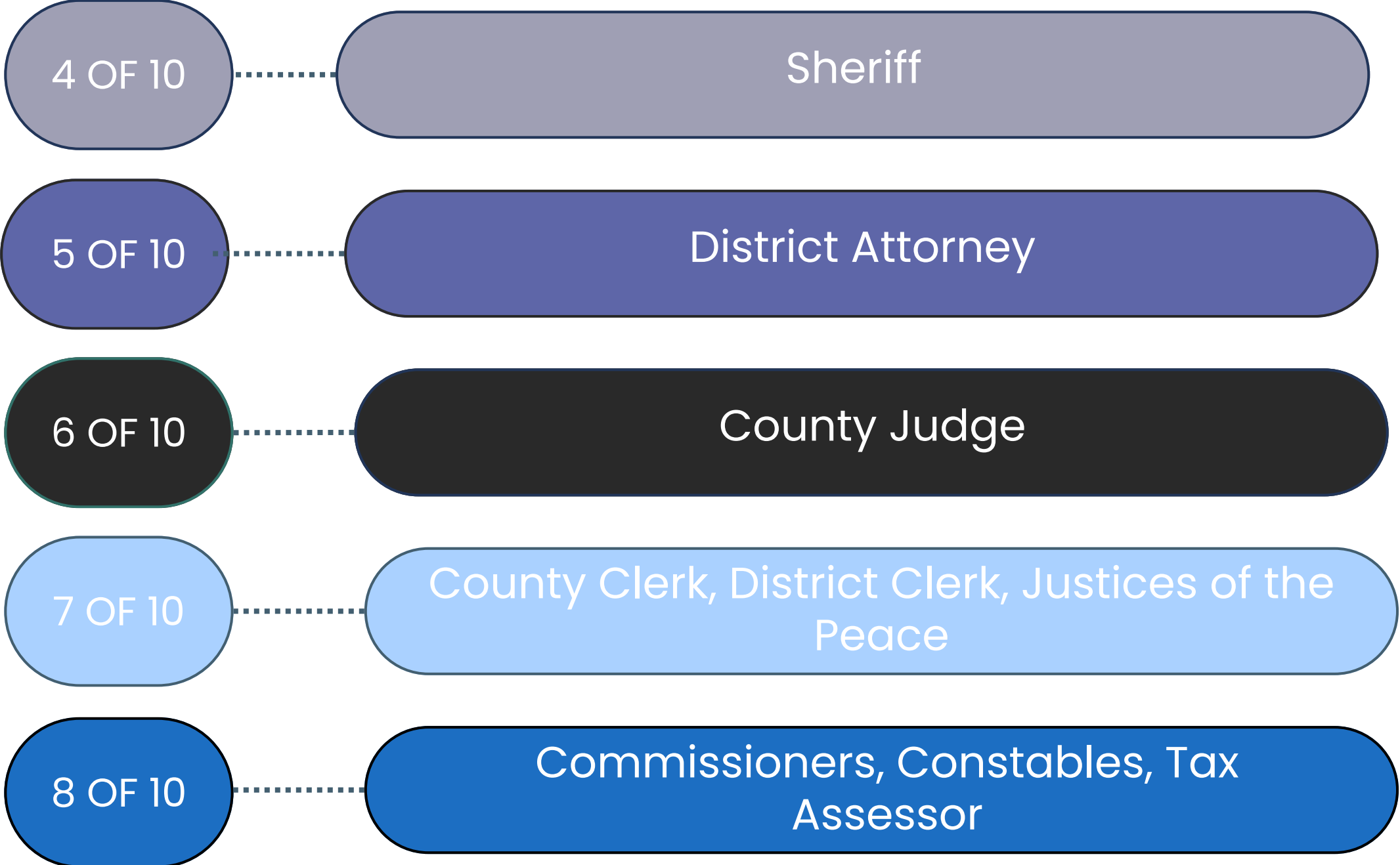

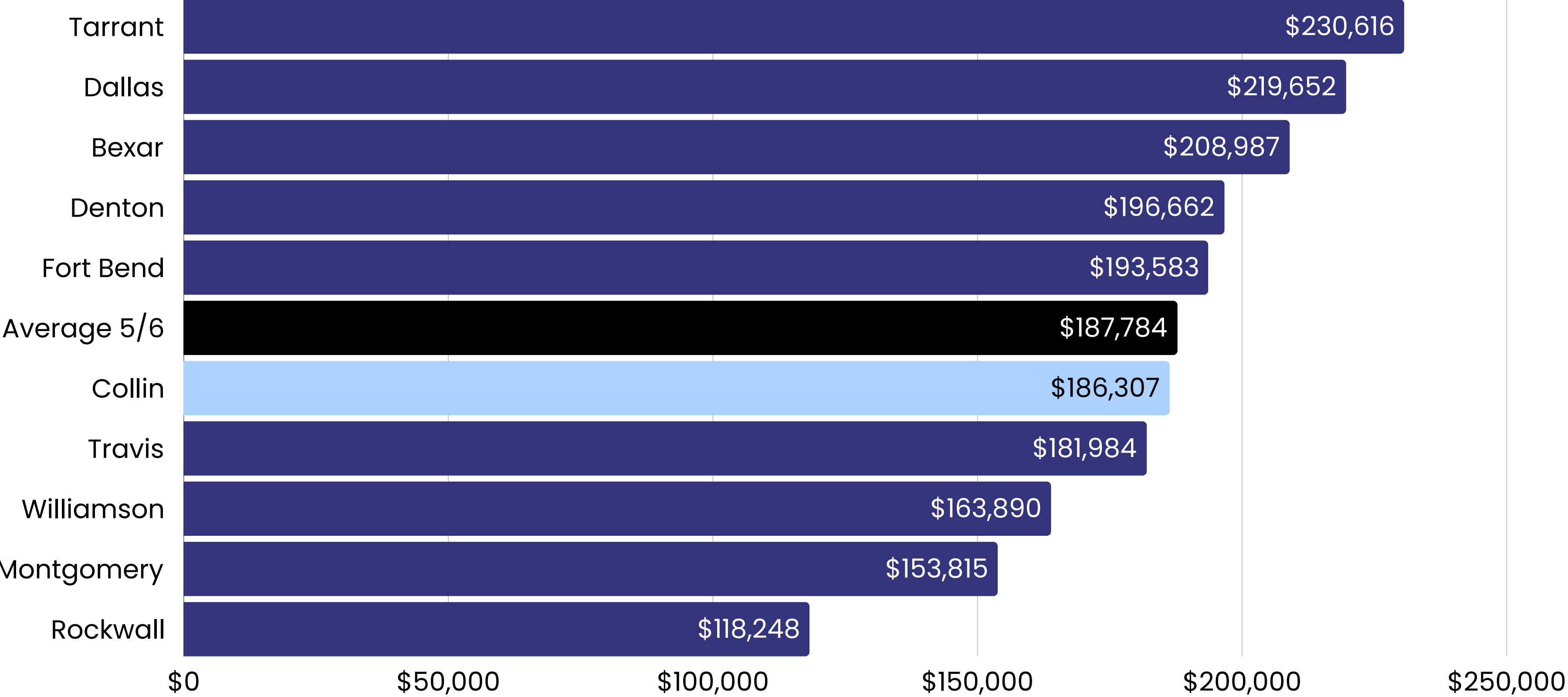

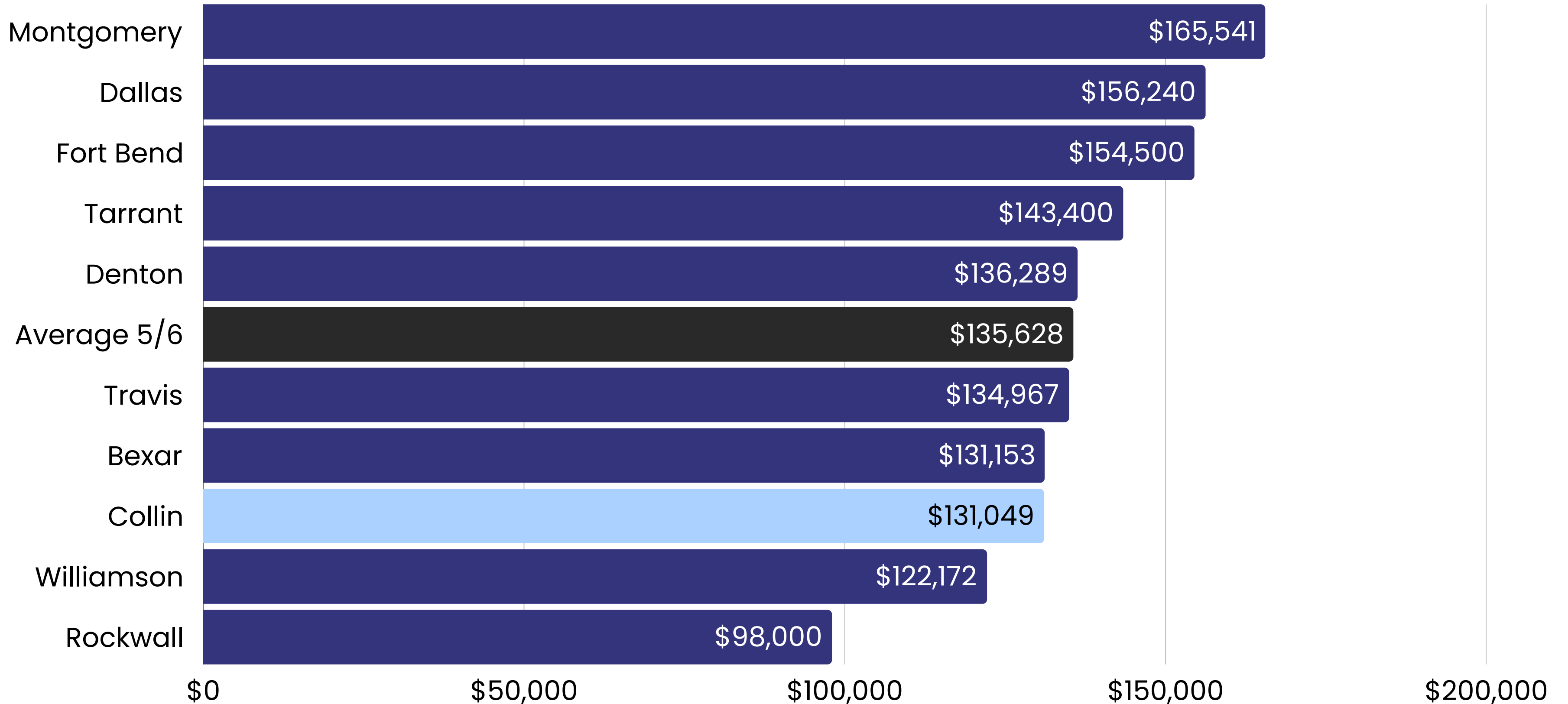
COUNTY JUDGE – FY2026



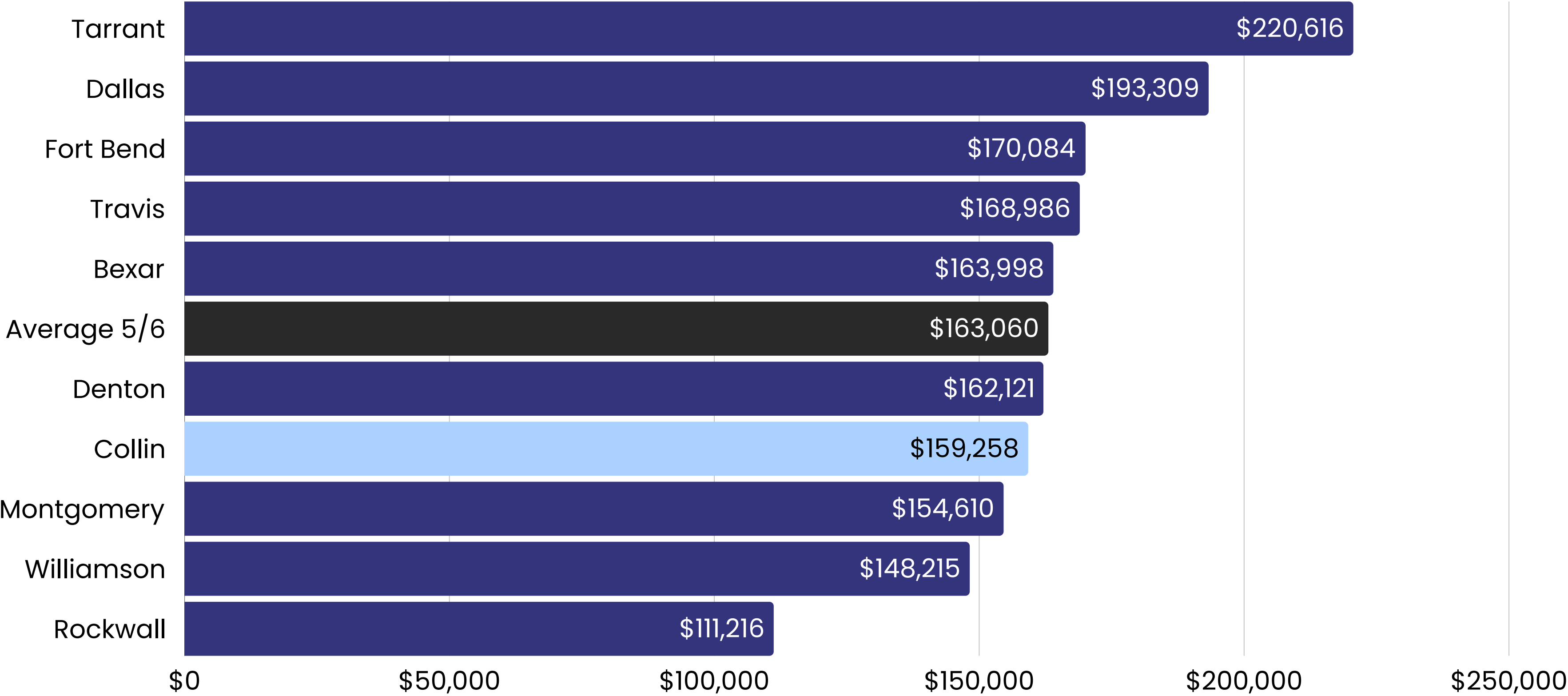
COMMISSIONERS – FY2026



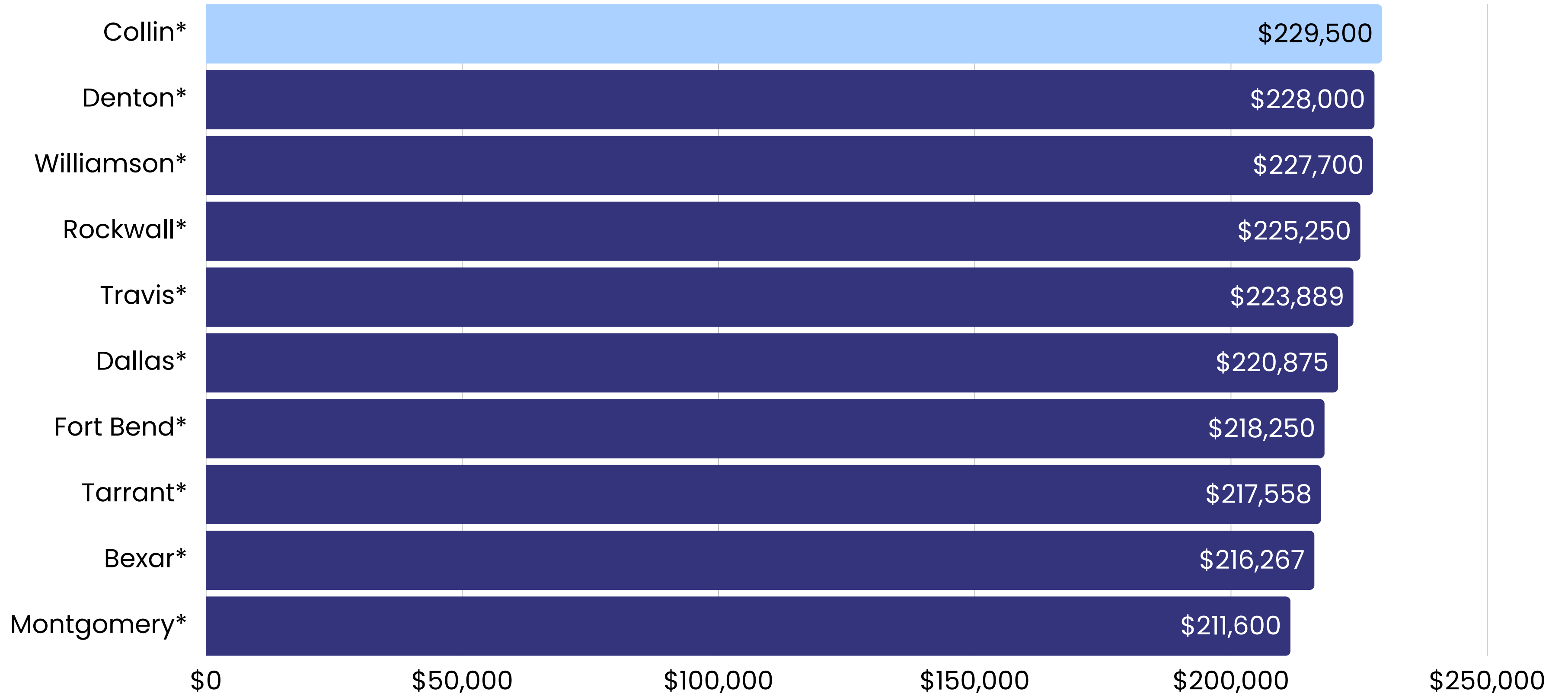
CONSTABLES – FY2026

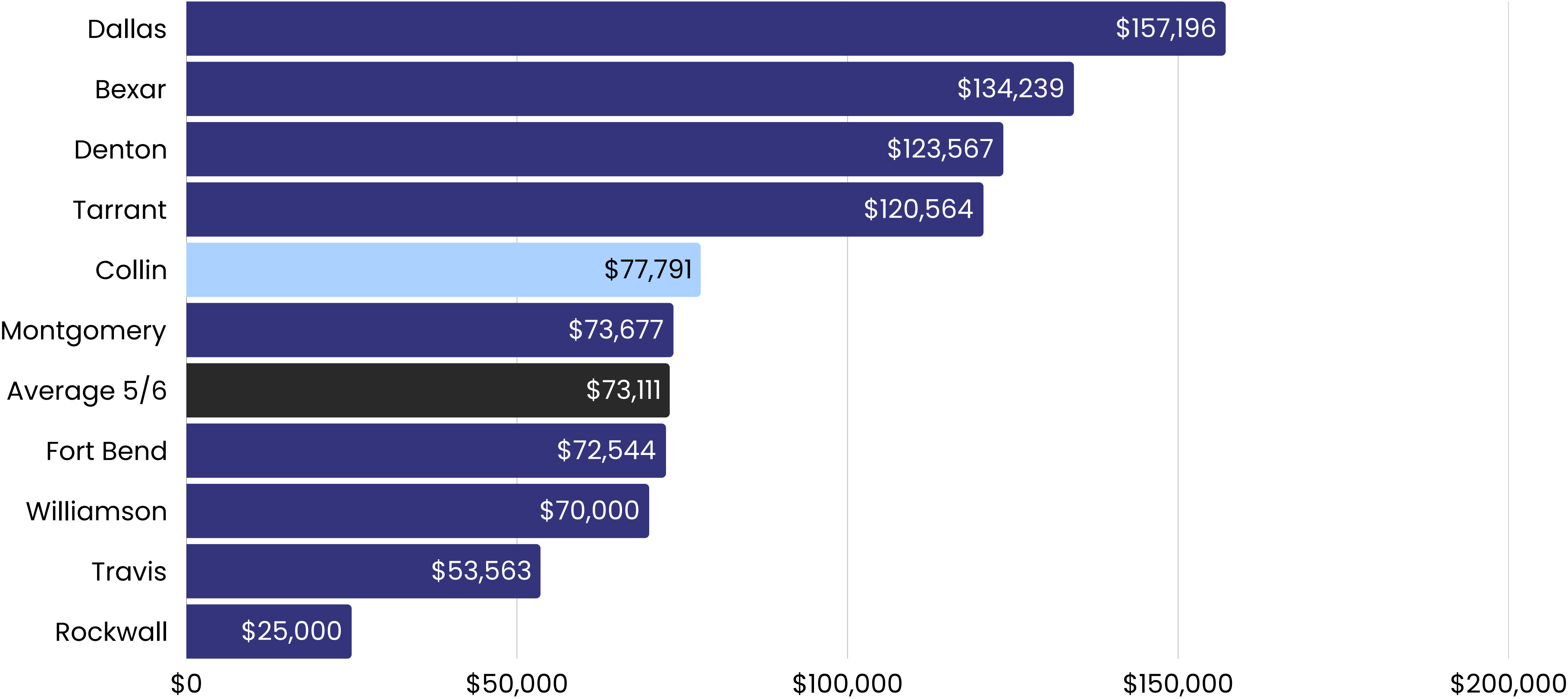
COUNTY COURT AT LAW JUDGES – FY2026



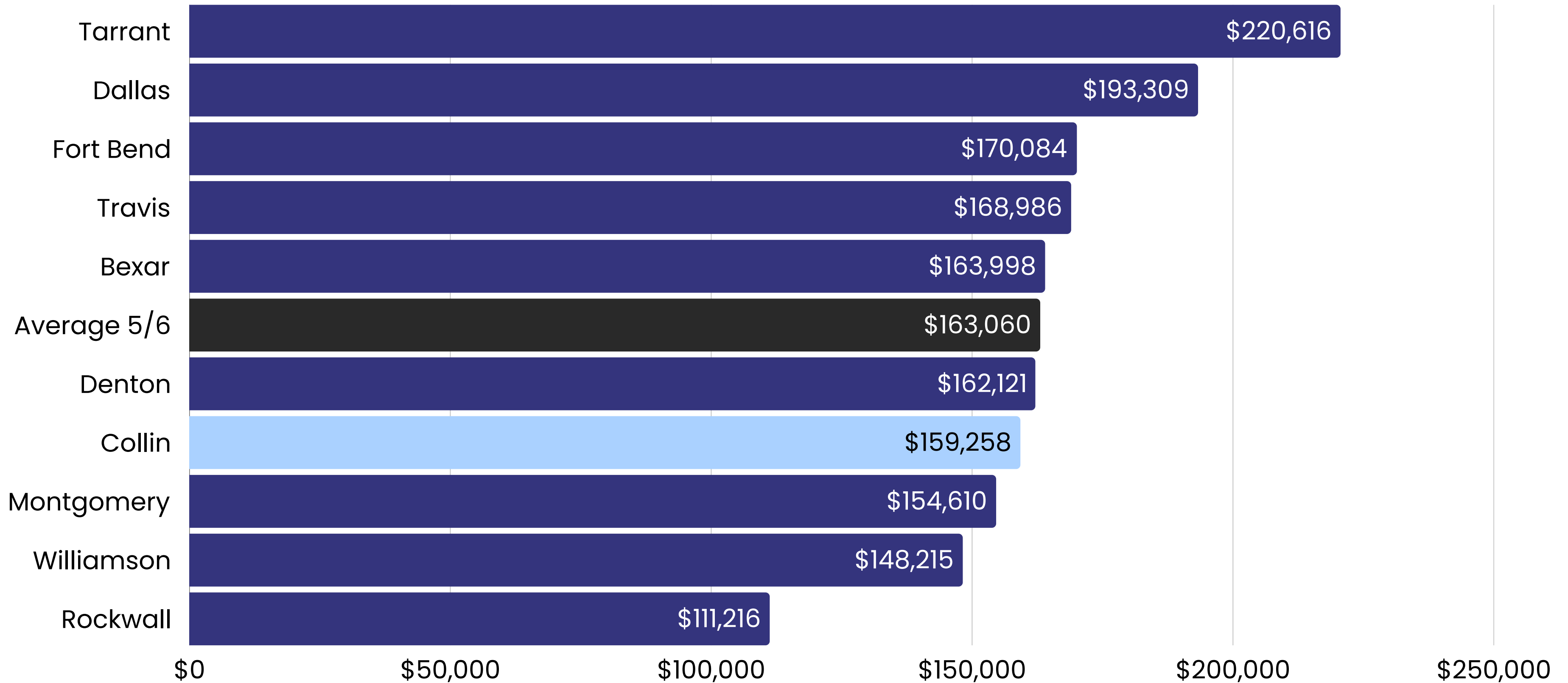

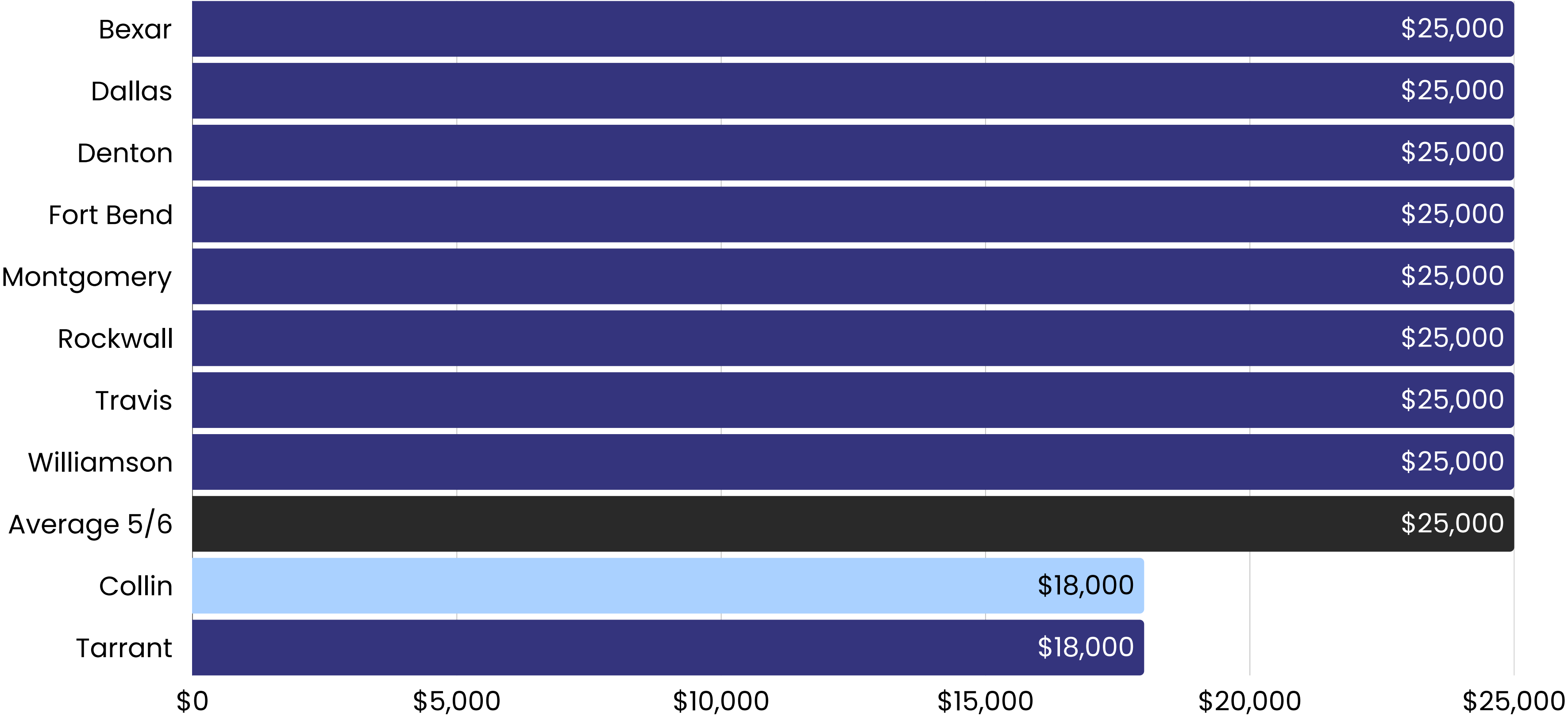
DISTRICT ATTORNEY – FY2026



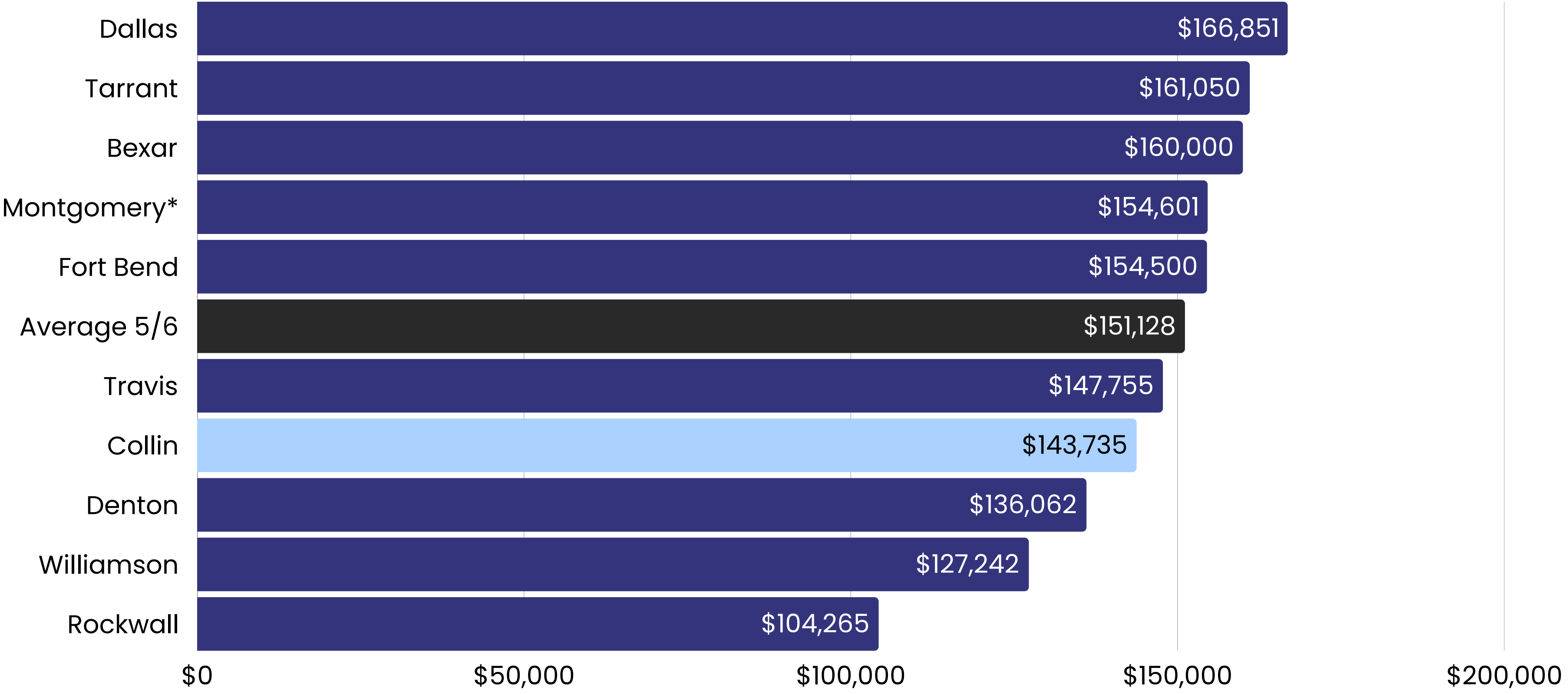
DISTRICT CLERK – FY2026



DISTRICT JUDGES – FY2026

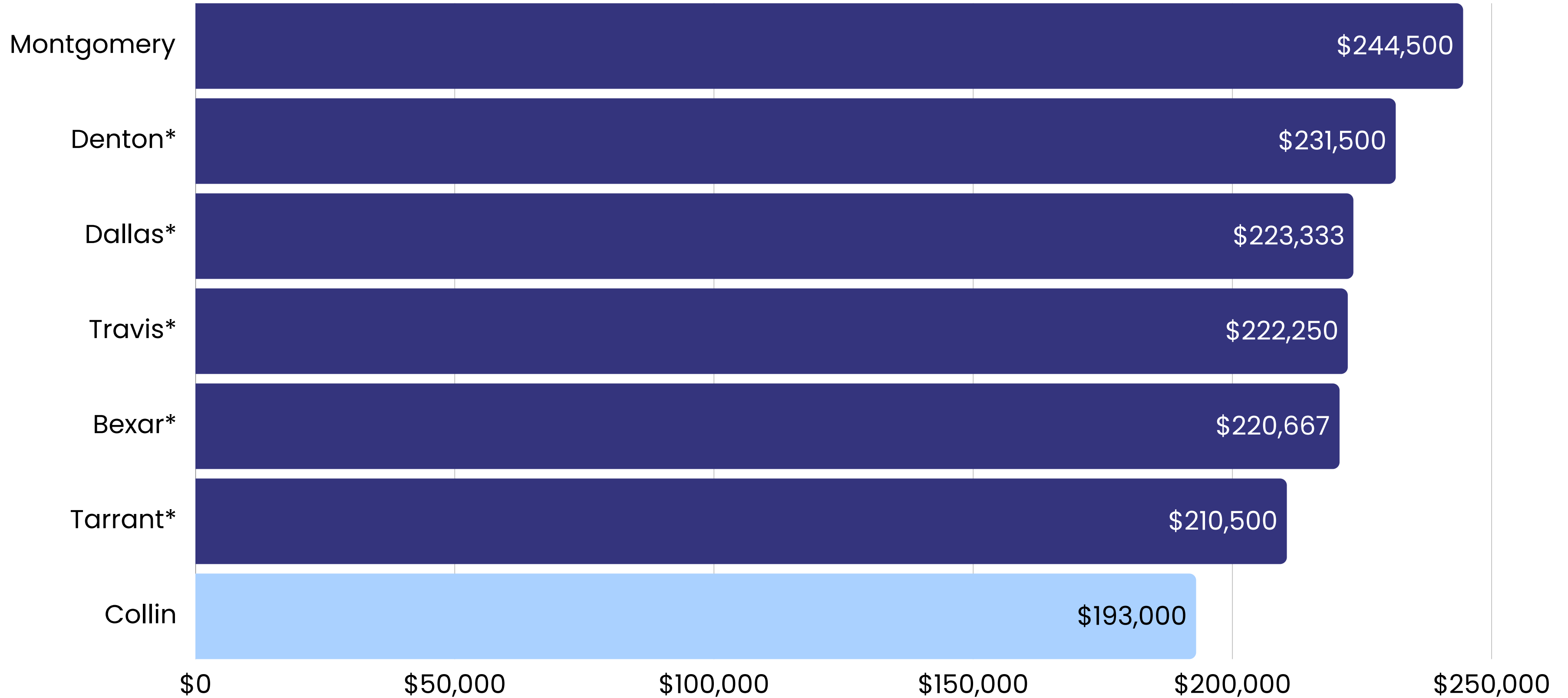


JUSTICES OF THE PEACE – FY2026

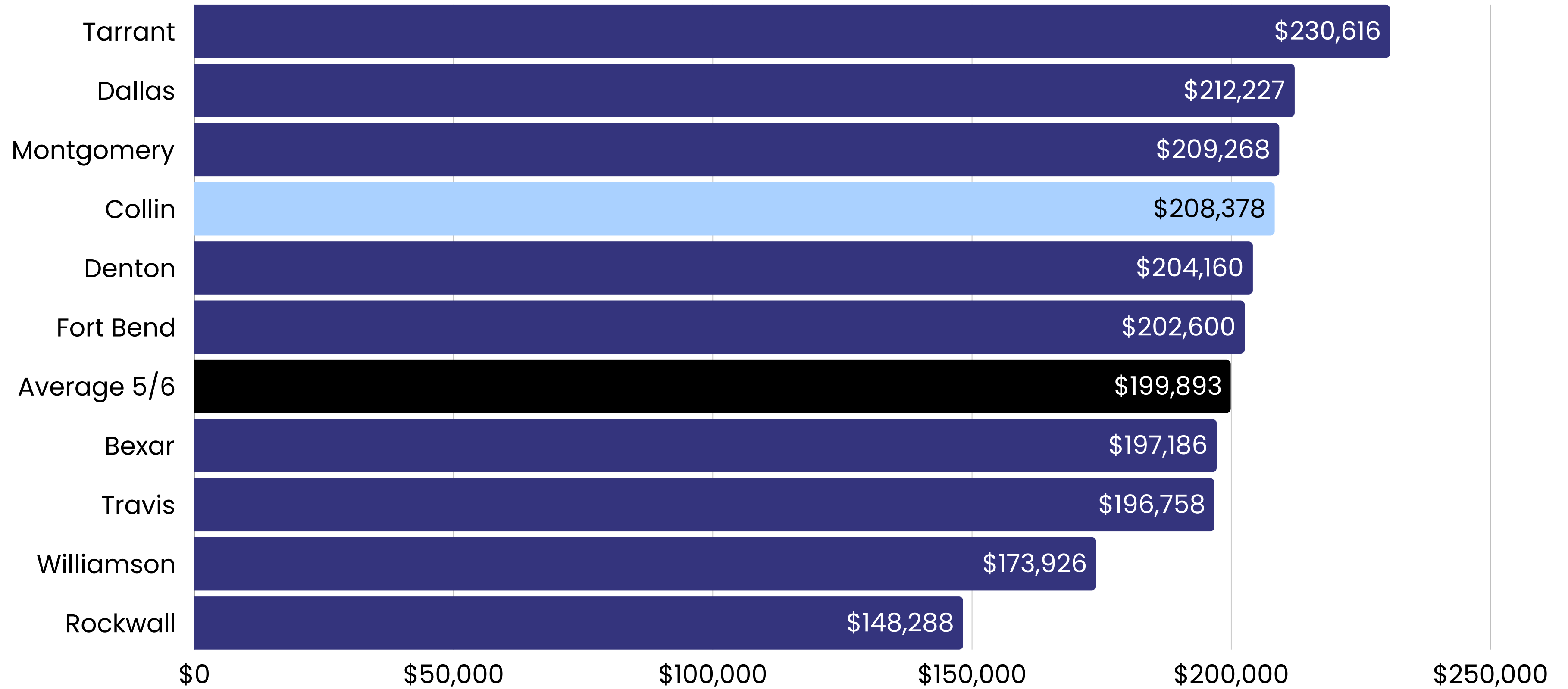
PROBATE JUDGE – FY2026
